I: Strategic level: Strategic Objectives (SO) and Specific objectives Indicators are at the outcome level. They are monitored by the Inter-Cluster Coordination Group (ICCG).


II: Cluster level: Cluster Objectives and Cluster Activities Indicators are at the outcome and output levels. They are monitored by the Cluster Coordinators.

III: Projects:

Indicators are at the output level. They are monitored by the project owners, who report to the corresponding cluster.

While acknowledging the importance of all levels of monitoring, this monitoring plan measures the progress of the collective humanitarian response by focusing on the upper two levels, i.e. Strategic Objectives and Cluster Objectives. The monitoring framework at the end of this document provides a detailed presentation of these objectives and indicators, with baseline, need, targets, and all parameters defining when and how they will be measured.

Further to this, financial inputs are monitored through the online Financial Tracking Service (FTS) platform.



The measure of indicators

The monitoring framework details how each indicator will be measured. This includes the following parameters:

Indicator label: the precise description of what is being measured

Baseline: the value of the indicator before the planned action started

Need: the total need for the group considered for the indicator, i.e. the ideal target

<u>Target:</u> the intended value of the indicator after action, i.e. the realistic target

<u>Data source:</u> where the indicator measure will be found

<u>Data collection method:</u> what method will be used for collecting the data

Data collection frequency: when the data will be collected along the year

<u>Data collection responsible:</u> who is in charge of collecting this data

<u>Data validation responsible:</u> who is in charge of validating the data

Data storage: where the data will be stored

Each cluster will also elaborate on achievements towards cluster objectives, any changes in the context, challenges faced, and recommendations to address gaps in the response.

- An end-of-year report will be produced in January of the following year.

This report will present final indicators values, achievements, successes and challenges, and an analysis of funding.

- Monitoring data and information will also inform the next Humanitarian Needs Overview (HNO), and the Global Humanitarian Overview (GHO) prepared at the end of the year.

Roles and responsibilities

HC/HCT:

- Endorse the humanitarian response monitoring plan
- Ensure adequate financial and human resources to implement the monitoring actions
- · Receive and discuss the reports submitted, and act upon recommendations
- Decide on the dissemination of reports to stakeholders and the general public

OCHA:

- Appoints a monitoring officer/focal point
- Coordinates all inter-cluster efforts as mentioned below (ICCG)
- Regularly updates the HC/HCT on the progress of the humanitarian response, with monitoring data and financial updates
- Disseminates reports as agreed by the HCT, and uploads them to the country's website
- Provides the required information to OCHA HQ for the Global Humanitarian Overview (GHO)

Inter-Cluster Coordination Group (ICCG):

- Develops the humanitarian response monitoring plan, and revises when necessary
- Ensures adequate resources are provided to conduct the planned monitoring work
- Monitors and reports against strategic objectives and specific objectives indicators
- Produces online and pdf reports as scheduled, based on consolidated cluster and inter-cluster information, data, and analysis

Cluster Coordinators:

- Appoint a monitoring officer/focal point
- Write specific cluster monitoring plans, with indicators attached to cluster objectives and cluster activities
- Allocate adequate resources to collect and consolidate cluster monitoring data
- Provide cluster members with adequate tools to report on their projects in a consistent manner
- Ensure cluster monitoring activities are effectively undertaken by cluster members
- Aggregate and analyze monitoring data and information against cluster objectives and indicators, and provide them to the ICCG for the production of reports as scheduled

Cluster Members:

- Appoint a monitoring officer/focal point
- Contribute to developing cluster monitoring plans, in close collaboration with the Cluster Coordinators
- Allocate adequate resources towards field monitoring activities
- Regularly report project output data in the tool(s) proposed by the Cluster Coordinators.


Resources
